# LACONIA HIGH SCHOOL FACILITY UPGRADES AND IMPROVEMENTS

# REQUEST FOR QUALIFICATIONS (RFQ) FOR GENERAL CONTRACTORS

The Laconia School District is soliciting Statements of Qualifications from GENERAL CONTRACTORS interested in serving as Prime Contractor for a BUILDING CONSTRUCTION CONTRACT associated with upgrades to the existing Laconia High School.

#### **INTRODUCTION:**

The Laconia School District has appropriated funds to upgrade the existing kitchen/cafeteria, renovate existing restroom facilities and adding mechanical ventilation to portions of the existing High School. The funding source for the project will through federal funds (through the Elementary and Secondary School Emergency Relief Funds (ESSER)).

Project construction delivery will be by pre-qualified Prime Contractor/Competitive Bid. The project construction is anticipated to start in May 2023 and will occur over two summers construction seasons (2023 and 2024).

#### **DESIGN TEAM:**

Rist-Frost-Shumway Engineering (RFS) has been retained by the School District to be the prime consultant for all engineering, architectural, and other professional services for this project. RFS will provide general administration and project management, and will also provide civil, structural, mechanical, electrical, plumbing/fire protection, and telecommunications engineering. RFS has retained Marinace Architects (MA) as their subconsultant to provide educational programming and architectural design services.

  - a. Public K-12 educational facility projects.
  - b. Projects of a \$5 million scale or larger.
  - c. Projects with complex phasing and owner occupancy of site throughout construction.
  - d. Projects incorporating sustainable design, high performance design, and green design strategies.
- **Tab 4** References for the representative projects and key personnel identified in Items 2 and 3 above.
- **Tab 5** Description of the firm's current workload commitments, and the firm's capacity to participate in this project.
- **Tab 6** Documentation of financial solvency and appropriate bonding capacity.
- **Tab 7** Other information you consider pertinent to your firm's consideration.

The LSD has appointed a sub-committee to evaluate responses to this RFQ, based on the above criteria. The sub-committee will recommend pre-qualified General Contractor candidates for School Board review and action.
